### **Resolution to Require Senators to Attend Registered Student Organization Meetings**

---

Short Title: A resolution to require college senators, the international senator, the non-traditional senator, the military science senator, the honors college senator, and any at-large senators to attend registered student organization meetings hosted by respective constituencies in order to better represent the concerns of students.

- Whereas, it is the mission of the Student Government Association to represent the common voice and interest of all students as well as be proactive in seeking student opinion; and
- Whereas, the senators along with the Campus Collaboration Commissioner will compile a list of registered student organizations within each constituency; and
- Whereas, senators will be required to attend a minimum of one registered student organization meeting per semester within their constituency; and
- Whereas, senators will be required to complete the “Registered Student Organization Outreach Form” summarizing the organization meeting including any recommendations to the Student Government Association; and
- Whereas, “Registered Student Organization Outreach” forms must be submitted to the Student Government Association Campus Collaboration Commissioner for review; and
- Whereas, failure to complete this mandate will result in one absence per semester.

BE IT THEREFORE RESOLVED BY THE STUDENT GOVERNMENT ASSOCIATION OF  
ARKANSAS STATE UNIVERSITY THAT:

1. Student Government Association senators will attend a minimum of one registered student organization meeting per semester to gather student feedback in order to better represent student constituencies.
2. At the completion of the RSO meeting, senators will fill out a “Registered Student Organization Outreach” form to be submitted to the Campus Collaboration Commissioner.
